COMMUNITY ACCESS/INDUSTRIAL PARK/AGRI-BUSINESS GRANT PROGRAM

Community Access Grants are state funds for towns less than 5,000 in population and are for the construction or reconstruction of major streets in town such as Main Street and roads that lead to elevators, schools, hospitals, and farm-to-market roads. This program provides for 60% of the construction costs of the project, not including engineering or utility work. Grant size is limited to \$400,000.

The Industrial Park and Agri-Business Grant Programs provide funds to assist communities and counties who have a new industry or agri-business and need new or expanded access to the facilities.

Applications for all three programs are due July 15. Only applications for new projects will be considered. If you have projects that may qualify for this program please contact our office.

ASSISTANCE TO FIREFIGHTER GRANTS

Free workshops will be held around the country to provide information about the submission of competitive applications under

the 2011 Assistance to Firefighters Grants program. The workshop lasts about two hours. Interested representatives from fire departments as well as representatives from non-affiliated EMS organizations are invited to attend the workshops. Information will be presented on program changes, program priorities, eligibility requirements, and the application process. General assistance in writing a competitive narrative for a department's grant application will also be covered. Registration is not necessary. Local workshops include:

SCHOOL LAB CLEANUPS

SDDENR was appropriated \$750,000 as part of the 2011 Omnibus Bill. This will assist the department to continue its efforts to fund the statewide cleanup of waste tires and other solid waste. This is a continuation of department efforts that began in 1999. DENR will continue to utilize the regional landfills as sponsors for the tire cleanups and other solid waste throughout the state.

The department will also use funds for the cleanup of laboratory chemicals that have been in storage on school district properties throughout the State. The department has received several Solid Waste Management Program applications for assistance in funding these clean-ups, and awarding subgrants through the statewide cleanup grant will allow the department to address these requests in a timely manner to promote a healthier

environment for students and staff. The department proposes to fund these projects with a one-time 50 percent grant up to a maximum of \$10,000 for each school district. This should allow many schools to safely dispose of lab chemicals which are no longer of use to the school. For more information contact either Stacy A.
